Utility-Scale Solar Construction and Leases for Land Use

Topics include understanding leasing agreements, an overview of water rights, and what to know about pipelines, including land use expectations and reseeded right-of-ways. A representative from the Ohio Department of Natural Resources Division of Oil and Gas Resources will also be present to answer questions.

Mineral Rights and the Dormant Mineral Act

Learn about what to know when considering leasing or selling mineral rights for oil & natural gas development from Extension Educator Dan Lima. Peggy Kirk Hall, Associate Professor and Field Specialist, Agricultural & Resource Law will discuss the Dormant Mineral Act and implications for land/mineral owners. A representative from the Ohio Department of Natural Resources Division of Oil and Gas Resources will also be present to answer questions.
